Textual Information(1)	The Company has allotted 61,18,574 Equity Shares to the promoter entity, Surplus Finvest Private Limited, pursuant to the conversion of 61,18,574 Convertible Warrants into fully paid-up Equity Shares. This conversion was approved by the Board of Directors through a circular resolution (30,00,000 Warrants Converted into Equity shares approved dated March 27, 2026 and 31,18,574 Warrants Converted into Equity shares approved dated June 13, 2026), in accordance with the applicable provisions of the Companies Act, 2013 and SEBI (ICDR) Regulations, 2018, and as approved by the shareholders at the Extra Ordinary General Meeting held on October 29, 2024. The said Equity Shares shall rank pari passu with the existing equity shares of the Company and were issued at a price of Rs.11.21 per equity share (face value of Rs.10/- each, including a premium of Rs.1.21 per share). At present, the shares allotted to the promoter are reflected in physical form, as the Company is in the process of completing the necessary formalities for dematerialization, including filing the listing application and initiating the corporate action with the depositories. The dematerialization of these shares will be completed shortly, in compliance with applicable regulatory requirements.
