#### Panchayat poll violence: 20 years on, 24 iailed for murder

SRAWAN SHUKLA / Lucknow

In a 20-year-old case related to murder and violence during the panchayat poll, a Behraich court on Wednesday sentenced 24 accused to life imprisonment. Cases against 6 others, who died during the trial, were set aside by the court.

Equipped with firearms, bombs and other weapons, 30 people had attacked a poll booth in Hariya Dolkua village in UP's Behraich on June 14, 2000. They tried to indulge in bogus voting and when opposed by supporters of other candidates, they opened fire, hurled bombs

and looted ballot boxes. While Ramesh Tiwari died on the spot, 7 others had received gunshot injuries in the attack. On a complaint by the deceased's brother, the police had registered cases against 30 accused under IPC Sections 147, 148, 302/149, 307/149, 323 and 171. After hearing final arguments, additional sessions judge (6th) Manoj Kumar Mishra-II con victed all the 30 accused.

#### Bhima Koregaon: Key evidence was planted?

#### Thinning of troops at Finger 4, admits China

Though both sides disengaged in the Galwan valley in July, the stand-off continued at critical points at Pangong and PP17A. In August, Indian troops gained control of multiple strategic heights in Chushul sector along the LAC, which changed the overall equation. According to a media report (ref: India Today), the understanding is that China will move back to Finger 8 and Indian troops will pull back to the Dhan Singh Thapa post between Finger 2 and 3. There will be no patrolling by either side at Finger 4. These sources added that while marginal thinning of troops has taken place, removal of tanks and weapons is yet to happen.

#### Newborns choked for 21 minutes...

Tope said on the fateful day, because of a short circuit, there were sparks for 12 minutes, culminating in a fire in the ward. However, it went unnoticed as the two nurses were not present on the job. The state government has already suspended district civil surgeon Dr Pramod Khandate, along with the on-duty medical officer of the hospital, Dr Archana Meshram. Additional Civil Surgeon Dr Sunila Bade has been transferred to a non-executive post while Paediatrician Dr Sushil Ambade has been terminated. The Nagpur Divisional Commissioner Sanjay Kumar, had, in his report, observed that the hospital administration's lapses led to the fire which occurred between 1 and 1.30am on January 9. The report had held civil surgeon Khandate and additional civil surgeon Bade responsible for negligence and the hospital suffering from lack of maintenance. The report stated that on duty nurses AmbilDuke and Sathavane were not at their nursing station at time of the fire. Sister in charge Jyoti Bharaskar, who was suspended, was held responsible for not ensuring that the nurses were present at the nursing station. Medical officer Meshram and paediatrician Ambade have been held responsible for not being present at the SNCU at the time of the incident though they were on duty there.

#### Kangana takes a 3600 about-turn

The bench of Justice Chavan had, in an earlier hearing, granted 2 weeks to the actress to spell out if she would approach BMC. Accordingly, on

Wednesday, when the matter was called out for hearing, senior counsel Dr Saraf told the judge his client had decided to withdraw the plea.

#### A pious movement has been dishonoured: PM

He also underscored that India will emerge as a strong player in a postcoronavirus world. "The post-COVID world is turning out to be very different. In such times, remaining isolated from global trends will be counter-productive. We'll have to emerge as a strong player. That is why, India is working towards building an Aatmanirbhar Bharat," the prime minister said. He asserted the farm laws enacted in September are not binding on farmers but are optional and give them additional choice. He challenged the farmers to prove to the contrary, if anything has been snatched from them. He described the continuous ruckus by the Opposition, while he was replying to the debate in the Lok Sabha, as a well-thought out strategy to drown his submissions.

As Modi spoke about the laws and the protestors, most Congress MPs staged a walkout from the Lok Sabha. Unlike his combative speech in the Rajya Sabha on Monday, Modi kept his cool despite 20 minutes of din and pandemonium, until it died down, to let him speak without any further interruptions. He said his government wants to take the nation forward and cited the decisions taken by it nobody had called for; the farm laws fell in this category.

Explaining why his government has been opposed to status quo since he came to power, Modi said there have been no investments in agriculture and therefore the urgency to modernise and make farmers self-dependant. The Prime Minister said 80 to 85 per cent of those engaged in agriculture are small farmers, whose fragmented holding are becoming smaller and smaller; he recalled the late Prime Minister Chaudhury Charan Singh having said that a day will come when the holdings will be so small that a farmer won't be able to even turn a tractor in his field. The PM cited how the number of farm labourers has gone up from 28 per cent to 55 per cent; their land holdings have become so small that they are compelled to work in others fields.

#### Corona's blow: Maha Govt fiscal deficit to be 6%-7%

Another minister said that the state government, during the current fiscal, had resorted to overdraft from the RBI. "However, for Feb and March, the government will not need the overdraft, as it has made the necessary provision," he added. However, the government will be forced to curtail the Rs4.5 lakh crore budget by Rs 1 lakh crore. Between April 2020 and January 2021, the state's income was only 54 per cent of its target for 2020-21 and it was 20 per cent lower than its income for the corresponding period in 2019-20. The state had generated Rs 1.88 lakh crore in revenue till January-end. Pawar, in his annual Budget for 2020-21, had set a revenue target of Rs 3.47 lakh crore. In 2019-20, the state had collected Rs 2.37 lakh crore in revenue by the end of January 2020, which was 75 per cent of the target. The state's collection of major taxes is down 53.6 per cent of the target, while nontax revenue is 47.3 per cent of the target. Further, the state had received 52 per cent of its target in the share of Central taxes by the end of January, as against 66 per cent in the corresponding period last year.

Bandra, CSMT restoration projects chugging away

Likewise, CR has received funding for the restoration of CSMT world-class UNESCO station and its transformation into a world-class museum. For the conservation of CSMT, senior CR officials said they had received Rs60 lakh in this Budget. They received Rs10 lakh for the first time, to facilitate the conversion of the existing heritage building into a world-class museum at a cost of Rs 25 crore. "We have carried out major works in the restoration of this world heritage site during the lockdown, on this Rs51crore project," said a CR official. Sculptors from Rajasthan have been called in to repair the dilapidated gargoyles, and restoration of certain granite and marble work is on the agenda. Also on the to-do list is the cleaning of the dome and its walls, with drones having been deployed to identify cobwebs and dusty spots. The terminus staircase leads to the first and second floors, which are a blend of Victorian Gothic Revival and Indian architecture. The dome has small rectangular green, grey and sand tiles in a combination. The project has been divided into sub-works. such as the restoration of the western facade (facing DN Road), the stained glass work, and the restoration of the sky-lit concourse.
